

Prince Georges Housing Committee Meeting Wednesday, October 23rd, 2024 3:00 PM – 4:30 PM Via Zoom Agenda

1. Welcome/Introductions

- The meeting commenced with introductions.
- A review of the minutes from August 2024 was conducted. No objections were raised, and the minutes were approved.

2. Discussion of Potential Developer Partnerships

- **Presented by Ahmna Khan:** Updates on potential partnerships with developers for housing units at 201 Hampton Place and 226 Penn Place.
 - o Both properties are transportation-accessible and in proximity to amenities.
 - Jericho Apartments, a senior living residence, may lease units to individuals with disabilities. This facility includes private transportation for residents.
- Members discussed suitability for clients and compliance with fair housing requirements.
- Action: Ahmna will follow up with developer contacts for more information.

3. Universal Design Committee Update

• Presented by Tierra Medley:

 The Universal Design legislation (CB 85) mandates accessibility in new housing developments in Prince George's County by January 2026.

- Provisions include ADA compliance, waivers for developers, and penalties for non-compliance.
- Updates were shared on the implementation process and collaboration between stakeholders.
- Questions were raised about council approval processes and next steps.

4. DHCD Updates

• Presented by Ahmna Khan on behalf of Chelsea Hayman:

- New guidelines under the Violence Against Women Act (VAWA) for HUDfunded properties.
- Updates on the DDA Rent Subsidy Program: 11 participants housed, 11 seeking housing, and challenges due to credit and background checks.
- o Members were encouraged to contact DHCD for support with property owners.

5. Mainstream Voucher Updates

Presented by Diane Dressler:

- HUD introduced new guidelines for mainstream vouchers, including extended search times and removal of residency restrictions.
- Unfortunately, Prince George's County does not have mainstream vouchers despite two attempts to secure funding.
- Members discussed potential advocacy and collaboration with council members to address the lack of resources.

6. Upcoming Events/Trainings

• Several members will attend the MACS conference next week.

7. Additional Updates and Open Forum

• Supported Living Opportunities:

- Lifegate, a supported living provider, offers an alternative housing model that includes subletting arrangements and rent contributions based on individuals' income.
- This approach was discussed as a viable option for individuals facing housing barriers.

• Housing Renovations and Challenges:

- o Ardmore faced regulatory challenges while remodeling group homes.
- Members discussed the need for streamlined processes for temporary relocations and more single-level homes for aging individuals.
